

Not all medicines should be supplied on NHS prescription!

You have received this leaflet as you have requested a prescription for something that is either available "over the counter" (OTC) from a pharmacy or supermarket or which has very little clinical evidence showing that they are safe or effective.

Many OTC medicines are cheaper to buy than a prescription charge. However many people who do not have to pay for their prescriptions will ask for a prescription for these items rather than buying them. We understand why families on a tight budget would want to do this. Unfortunately the NHS also has a budget and cannot afford to continue to supply these medications although some of the items may be available through local pharmacy minor ailments service (MK Pharmacy First) for patients who do not pay prescription charges.

The recommendation to avoid prescribing these items and direct patients to Self-Care wherever possible has the full backing of the Clinical Commissioning Group (CCG) and applies to all GP surgeries in Milton Keynes. Many other areas of the country have similar policies too.

We are sorry but we cannot prescribe the medication requested.
